**Ballots regarding Covenants:**

Motion on ballot to allow 14' room additions to campers by Tom Nichols, seconded by Ronnie Pierce. Carried.

Motion on ballot to remove references to Sewer Authority by Tom Nichols, seconded by AnnMarie DellaMorte. Carried.

The issue of allowing unattached garages in the camping area was referred back to the C&BL Committee.

Motion on ballot to remove references to setbacks from road right of way by Tom Nichols, seconded by Ray Robinson. Defeated

Motion on ballot to allow parking of campers, etc on owner's lots by Tom Nichols, seconded by Ray Robinson. Carried.

The issue of the reference to wells was discussed and referred back to the C&BL Committee.

Motion on ballot to allow screens and lattices on carports in the camping section by Tom Nichols, seconded by Ray Robinson. Carried.

**Ballots regarding By-Laws:**

Motion on ballot that the President run all BOD meetings by Tom Nichols, seconded by AnnMarie DellaMorte. Carried.

Motion to defeat placing ballot on assessing additional dues of \$25 for 2006 for gate security by Tom Nichols, seconded by Ray Robinson. Motion to defeat carried.

Motion on ballot to nominate 2 people for each BOD seat available by Ray Robinson, seconded by Bill Wakefield. Carried.

Motion to defeat placing ballot to assess additional dues of \$150 for 2006 and 2007 by Tom Nichols, seconded by Ray Robinson. Motion to defeat carried.

Motion on ballot to eliminate word "use" regarding dues on lots by Bill Wakefield, seconded by Tom Nichols. Carried.
