OBTAIN THE FOLLOWING

Driveway permit

Needed before any clearing or mechanical activity takes place on the lot.
Obtain at the POA office for a \$75 fee.

Soil & Erosion permit

Needed before any clearing or mechanical activity takes place on the lot.
Required for all projects disturbing 100 square feet or more.
Obtain at POA office (no charge)

Franklin County Health Permit

All lots must show evidence of a Franklin County approved system.

1) **FORM A ‘ CHECKLIST FOR APPLICANTS’**

Check that all applicable requirements are done.

2) **Structure** (elevation) or **blueprints** drawings.

You **must** submit drawings of the proposed structure showing the following:

- a) Top view or floor plan (including all decks, porches, bump outs, etc.)
- b) Elevation drawings (shows front, side & rear views of structure).
- c) Drawings may be hand drawn

3) **Misc:**

- Street #** (and lot #) must be posted and visible from the road.
- Permits must be visible from road
- Silt fence - see Soil and Erosion requirements

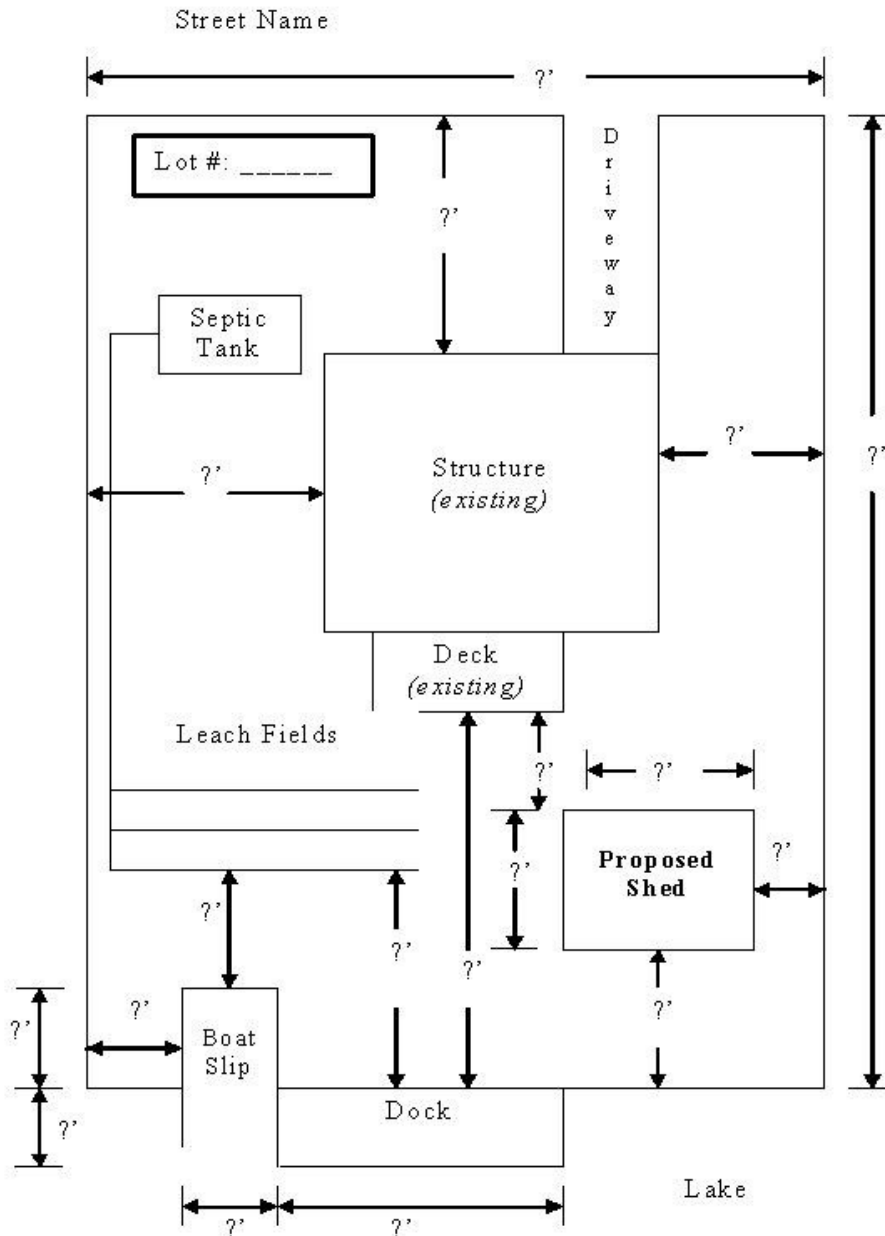

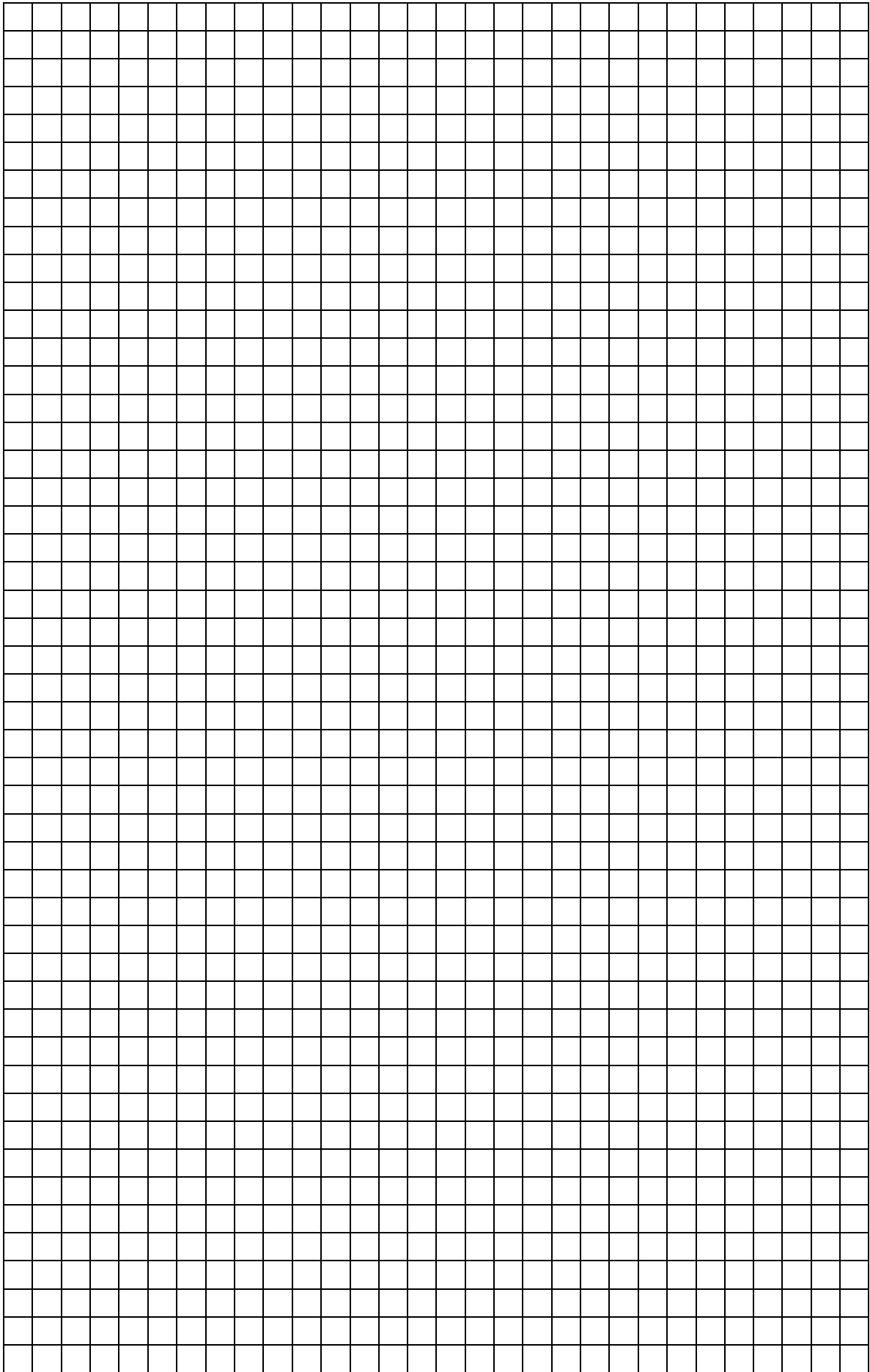

- Show the location of all property pins (Highly recommend survey)
- Show the exterior dimensions (between the property pins) of your lot. (Recorded plats available at Franklin County or Nash County planning offices.)
- Show the location of the street(s) and shoreline (if on lake)
- Show all present structures on the lot with distances to the exterior lot lines or natural shoreline.
- Show the proposed structure(s) location on the lot, with distances to the exterior lot lines(s) or natural shoreline.
- Show distances between structures – existing and/or proposed (all structure)
- Show driveway location.
- Show the location of the septic tank and its leach fields.
