### APPLICATION FOR WATER AND/OR SEWER SERVICE

The undersigned makes application to Total Environmental Solutions, Inc. ("TESI") for the supplying of water and/or sewer service, and in consideration of making the required deposit and/or tap and being furnished said service, agrees as follows:

1. Water and/or sewer taps are completed on a first come, first serve basis according to the date of application and at the discretion of TESI within 30 working days of application. Water and/or sewer taps will not be completed for any property owner and/or builder/contractor with an overdue TESI account. **Once completed and before buried, taps must be scheduled for inspection by TESI. If the tap is buried prior to approval by TESI, you will be required to expose the tap at your expense.**
2. Applicant agrees that in the event the water and/or sewer bill is not paid, TESI may use the said deposit to pay said bill. Applicant further agrees that in the event it is necessary to resort to said deposit to pay the bill, Applicant will pay an additional amount so that the said amount will at all times be maintained as a deposit. Applicant agrees that said amount is to be held as a guarantee of the bill, but on the expiration or cancellation of the Applicant's contract with TESI, the deposit, less any bills payable, shall be returned to the Applicant.
3. Applicant agrees to pay all bills rendered at the rate chargeable and further agrees that he will protect the water meter at all times and will guarantee its return to TESI in good condition.
4. Applicant agrees that the water meter installed is the property of TESI and further agrees that the meter is to be removed only by the employees of TESI. In the event that the water meter fails to register the amount of water used, either by reason of defect or any cause, TESI shall have the privilege of rendering an estimated bill for the period during which said meter has not registered. Said bill to be rendered will be based either by using the records of the newly installed meter as basis, by taking the corresponding period of the previous year of an average or by any other proper method.
5. Applicant, subject to the terms and conditions of this contract, has the right to utilize this sewer system, for the disposal of sewage only. No storm or down spout may be connected with this system in any way. TESI is given the right and privilege of inspecting property belonging to the Applicant to the purpose of determining such and in the case of low pressure sewer systems to inspect and maintain the grinder pump station.
6. Applicant agrees to make a separate application and deposit for service for each house and/or trailer built on the property now to be served and said Applicant further agrees to pay the proper water/sewer fees each month.
7. In the event the Applicant fails or refuses to pay monthly water and/or sewage bills, TESI may, at its discretion, terminate this contract after 45 days of nonpayment and Applicant shall have no further right to use said water and/or sewer service. In the event the service fees are not paid and TESI elects to terminate this contract, TESI has the option to disconnect the aforesaid service lines and before service is reconnected, Applicant agrees to pay for said reconnections.
8. It is understood and agreed that the water and or sewer line constructed by Applicant to his property line or grinder pump station, in the case of a low-pressure water system, is and shall remain the property of the Applicant.
9. In the event this agreement is not carried out and the water fee is not paid each month, the right to cut off the water/sewer service to the property at either the grinder pump, property line or at the main line is allowed by Applicant. If any part of the water/sewer main line is on part of the Applicants property, cut off rights shall remain and be vested with TESI without any liability for making said cut off.
10. The Applicant further agrees that necessary water/sewer easements over and across his property to install and maintain the system have been heretofore granted.
11. Service calls due to leaks in customers line will be charged to the customer at current charges.
12. Services turned on during weekends and /or holidays will be at overtime rates.
